IOPP | Simplify Tara India Opportunities ETF

FUND OVERVIEW

The Simplify Tara India Opportunities ETF (IOPP) seeks to provide long-term capital appreciation.

The fund will invest in equity securities of Indian issuers. It is actively managed with a goal of outperforming the MSCI India Index. IOPP is sub-advised by System Two Advisors, a firm with a deep bench of equity analysts and portfolio managers with a proven history in managing Indian equities.

PERFORMANCE REVIEW

IOPP outperformed the benchmark MSCI India Net Total Return Index by 3.59% in 3Q with a return of 10.88%. The fund has returned 24.51% since its March inception, bringing its outperformance since inception to 7.40%.

A number of factors helped propel the MSCI India Net Total Return Index to a record high by quarter-end: a market-friendly budget focused on infrastructure, employment, and consumption; continued solid foreign investor inflows; and a mildly favorable monsoon season which augurs well for agricultural production and inflation.

While some economic indicators pointed to a slight moderation in the pace of growth, it remained firmly in expansionary territory. IOPP's overweights in the Consumer Sectors—both Discretionary and Staples—and Communications contributed to relative performance as did avoiding the Energy Sector. In stock selection, out-of-benchmark positions in Financials and Information Technology also contributed positively.

DEFINITIONS

Market Price: The current price at which shares are bought and sold. Market returns are based upon the last trade price.

NAV: The dollar value of a single share, based on the value of the underlying assets of the fund minus its liabilities, divided by the number of shares outstanding. Calculated at the end of each business day.

SEC 30-Day Yield: The yield is calculated with a standardized formula and represents net investment income earned by a fund over a 30-day period, expressed as an annual percentage rate based on the fund's share price. The yield includes the effect of any fee waivers and/or reimbursements. Without waivers, yields would be reduced. This is also referred to as the "standardized yield", "30-Day Yield" and "Current Yield". The unsubsidized SEC 30-Day Yield does not reflect the effect of any fee waivers and/or expense reimbursements.
