



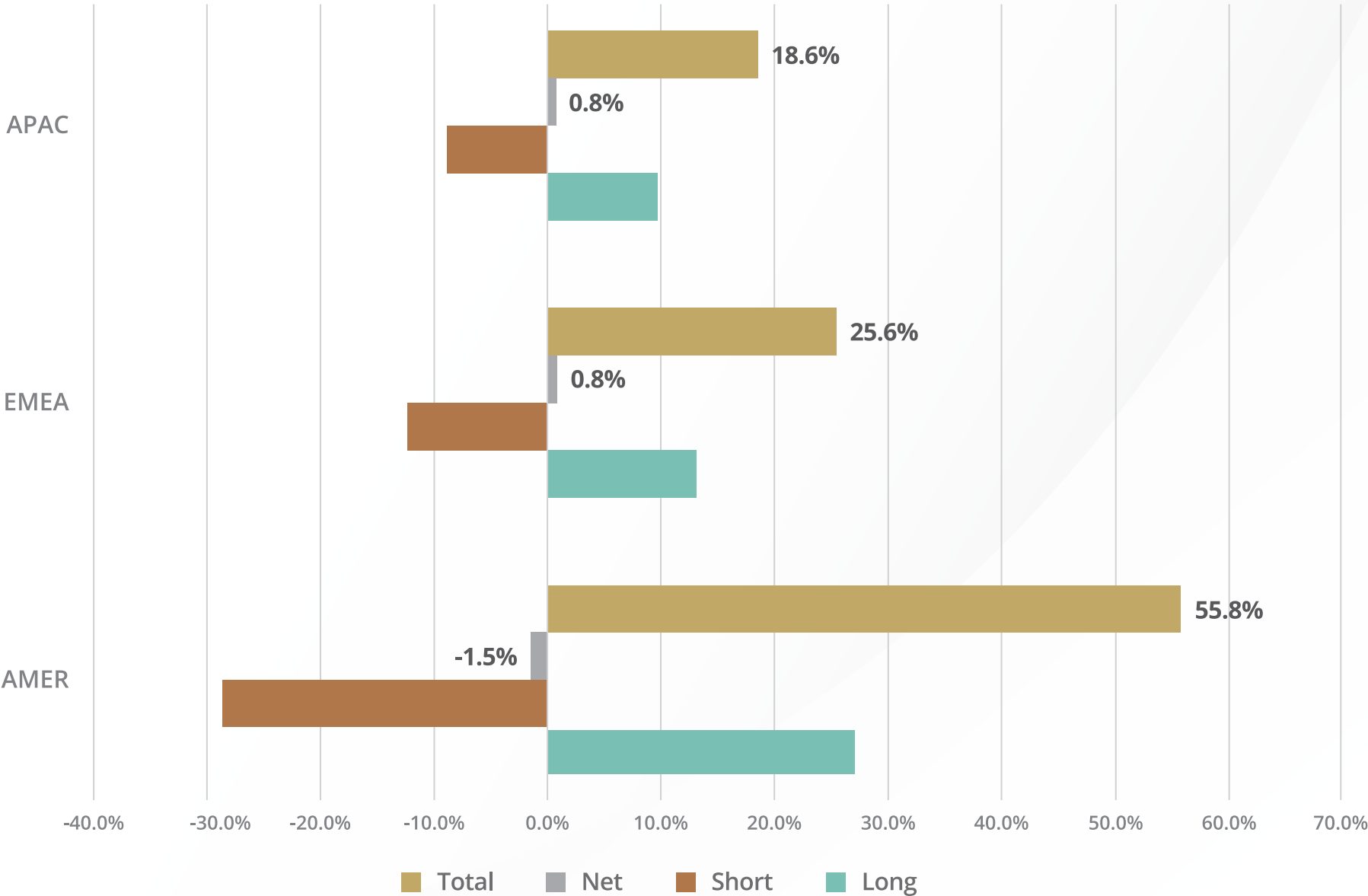

Exposure Breakdown

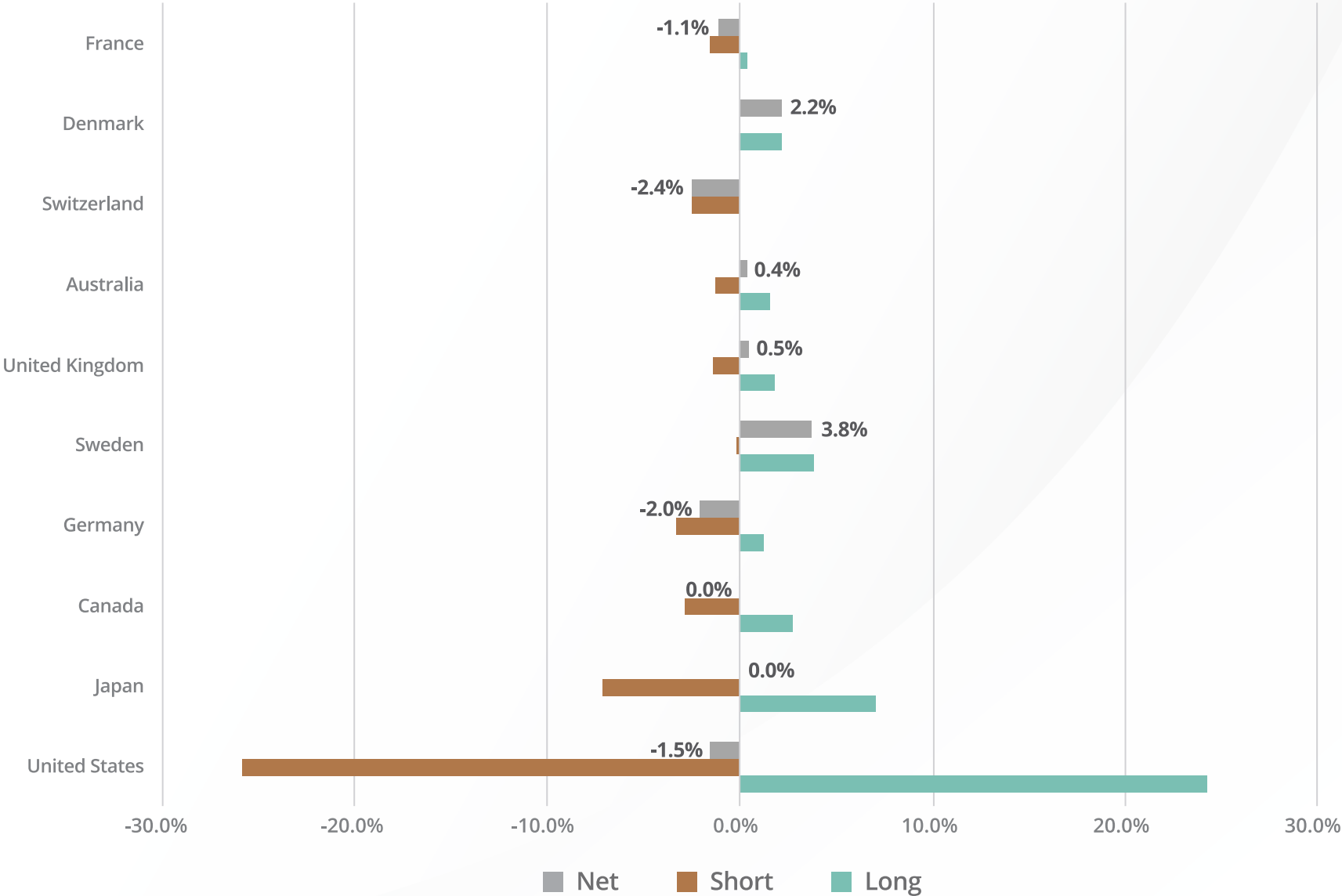
Region Exposure %

As of 3/31/24



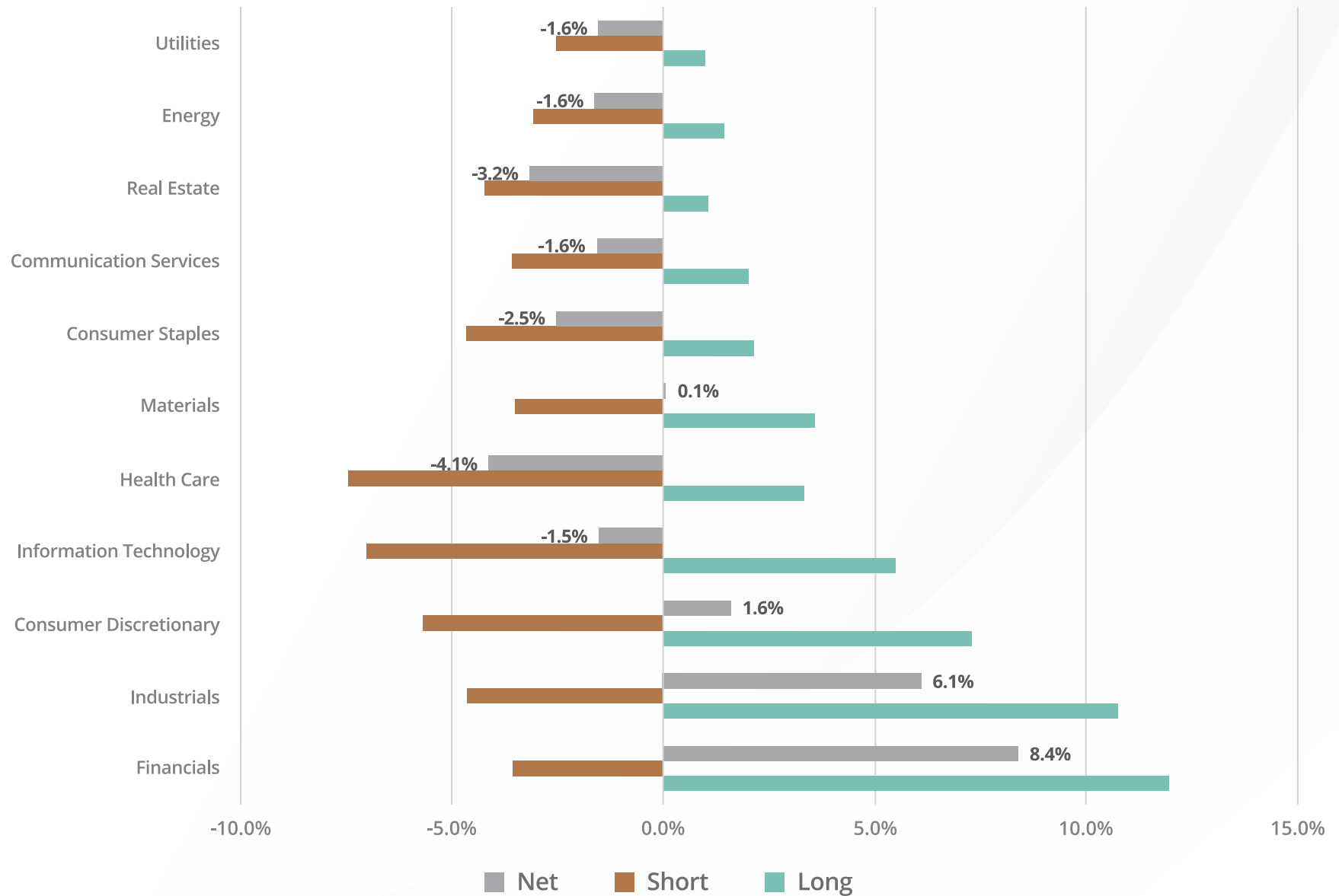
Top Ten Country Exposure %

As of 3/31/24



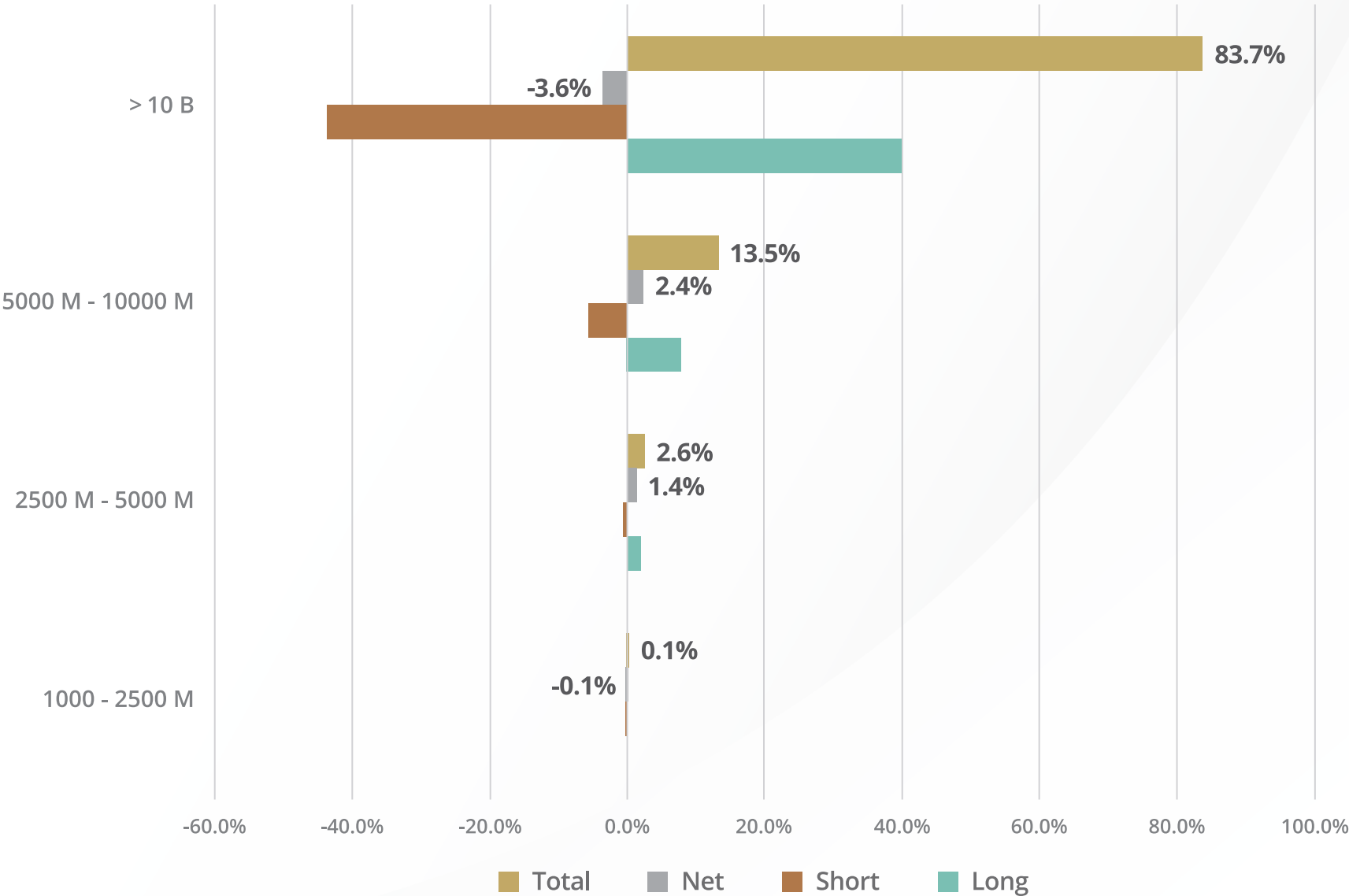
Sector Exposure %

As of 3/31/24



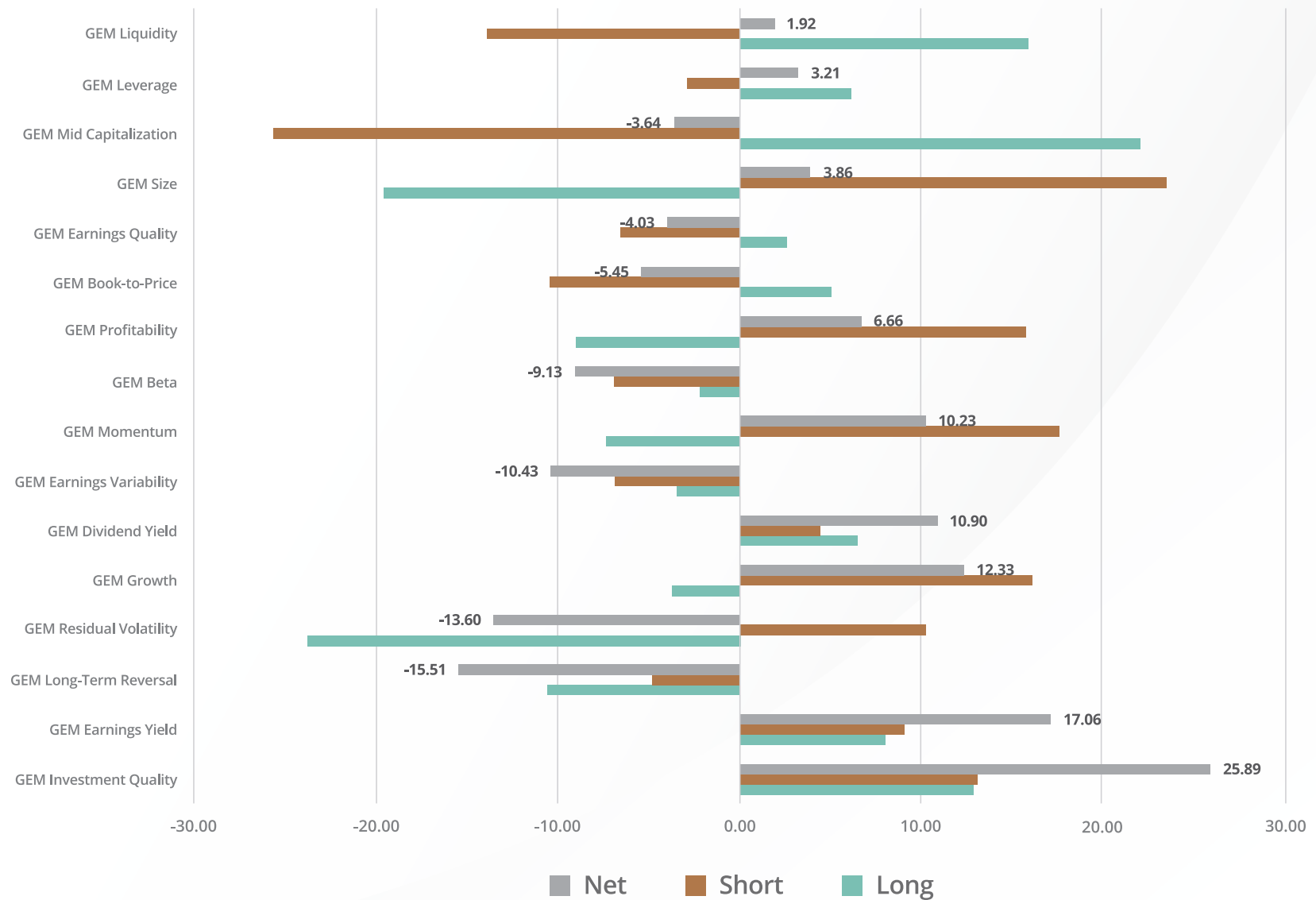
Market Cap Exposure %
